Milanofil 2010 Exhibition and Stampfair

"Italia 85" was a great philatelic event hosted in Rome by the Italian Post with the usual friendly organisation. But a major problem occurred, as the chosen hotel halls were not apt for housing such an event and furthermore a number of dealers were located in the floors underground and complained about this unpleasant position. The Italian Post recognized the issues and decided to offer a special compensation inviting the dealers to a newly planned event, to be held in the fine environment of the Fair of Milan, that had housed successfully Italia 76 and that would have then hosted Italia 98. This event celebrated the "Day of Philately 1987" and was so successful in attracting dealers and philatelists from all over Italy and from the nearby countries that it was decided to establish it as a recurrent one in the Italian philatelic agenda.

This philatelic trade event, held mid March and later named **Milanofil**, has been always combined with a stamp exhibition that was at national level already at the very beginning. Furthermore Milanofil has dragged along a similar event in Rome, **Romafil**, held in October also with a national exhibition in the well known Palazzo dei Congressi venue of Italia 2009. Usually Poste Italiane exploits both occasions for launching two or three new issues, and that draws many philatelists anxious to get the new



Mrs Giannini very proudly announced the results of Italia 2009: the issues devoted to this FEPA exhibition provided a net result of 11.8 Million Euro.

It was pointed out that this is an "incomplete" figure, as sales of said issues have been proceeding through 2010.

The success of Italia 2009, recognized in the speech of Jørgen Jørgensen, FEPA President, and the outcome of such business case induced a number of speakers, from Piero Macrelli, President of the Italian Federation, to Guido Podestà, President of the Province of Milan, to strongly support the idea of launching Italia 2015, matching the 2015 Milan Universal Exposition. If properly exploited, it would be a wonderful occasion for bringing philately live in a cosmopolitan context, well behind the borders of our usual philatelic exhibitions.

ALP-ADRIA-HUNFILA 2010 EXHIBITION

There are 7 countries in the Alps-Adriatic Region; thus, we can be certain that every 7 years it will fall to Hungary to organize the Alp-Adria exhibition. Our preparations began in Spring 2009 when we approached the mayors of the 5 or 6 larger towns in western Hungary capable of holding an international event of this kind to ask whether they would like to act as host to the philatelists. Sopron is one of the most westerly cities in Hungary and gave us a very warm response. They showed us the

"Cultural and Conference Centre of Liszt Ferenc" which offered a very good venue. It is located in the city centre, there was sufficient space on 2-3 floors for the exhibits, there were enough additional rooms for other needs and the staff were very experienced.

So we decided we organize the "ALP-ADRIA EXHIBITION 2010" in Sopron from 26-28 March. It is an old tradition in these 7 countries that we try to encourage young and beginner exhibitors so in most cases the exhibitions were organized in Rank II. However, in Hungary we also usually organize a national "HUNFILA" exhibition in the Spring with Rank I equivalence which also celebrates the "Day of the Stamp". It did not make sense to organize an exhibition for the Alp-Adria countries in March and another event 1-2 months later. Following discussion in our board we came up with the idea of organising the 2 exhibitions jointly but with the second one not holding a normal Rank I competition.

It is generally the case that exhibits which achieve good results at national level are subsequently entered in FIP / FEPA exhibitions and that, to obtain better results, the exhibitors invest in more and better items for their exhibits, very often rebuilding their material. This can create a problem in that philatelic friends in the exhibitors' own countries never have the opportunity to see and enjoy the improved exhibits. To address this we decided that, in addition to the Alp-Adria exhibition, we would hold an exhibition limited to material that had previously been shown in FIP and FEPA exhibitions abroad. To give additional interest we also organized a special competition for this "Master Class" with 2 prizes, one awarded by a special jury and the second by the public.

It was a great honour for us that Mr Jørgen Jørgensen, FEPA President, accepted our invitation to come and visited the exhibition during all 3 days.

What happened March

On the first day the Hungarian Post issued 2 stamps about the city of Sopron and one block about the famous Hungarian composer Erkel. At the Opening Ceremony, therefore, music by this composer was played by the teachers of the Music School in Sopron. We organisers are always eager for prominent people to cut the national ribbon at the start of an exhibition and in this case we were delighted that the exhibition was opened by several leading figures.

About 150 guests came to this event and in the first part they were able to form an impression of the Hungarian folk dance.

The regulations of the Alp-Adria organisation say that every exhibition has to award an Alp-Adria Grand Prix to the exhibit that best realizes the concept of the Alp-Adria Working Group. In 2010 this prize was given to Luigi de Paulis (Italy) for his exhibit, "Postal History of Friuli 1500-1850"

There was also great interest in who would win the HUNFILA Master Cup, representing the prize for the best exhibit in Hungary in 2010. The special jury team found this a difficult decision because 2 exhibits were awarded a very high mark, but in the event the winner was Mr András JAKAB for his exhibit: 'Austrian Post in Hungary 1850-1867'. It was very interesting that this, together with Mr Homonnay's exhibit, was awarded the large gold evaluation with 95 points some weeks later in London. This proved that the jury in Sopron had made a good decision. The third Grand Prix, the so called "Public Prize", went to Mr Peter Dunai for his thematic collection: "The Hungarian Holy Kings".

When it was all over everyone went home with a good feeling because the SOPRON exhibition had been a very successful event in the life of the Alp-Adria Working Group. Goodbye and see you in 2011 in the Croatian Republic in OPATIJA (Abbazia)!

Every year there is a meeting of the 7 Alp-Adria countries where they analyse the current event and decide about the organisation of future exhibitions. This organisation has a very democratic statute, e.g. the current president

holds his post only for 3 years and is succeeded by someone from another country.

- **4. Minutes of the 2009 Congress in Essen**. As the minutes of the 2009 FEPA Congress in Essen were sent to all National Federations, President Jørgensen asked the delegates for comments or questions. The minutes were confirmed unanimously.
- **5.Reports of the Board members**. All reports had been sent to the National Federations previously, so they were not repeated. Mr. Jørgensen explain that the number 17 of FEPA News magazine will be issued before summer, to be able of including the information of London 2010. Everybody was requested to send the news from his Federation as soon as possible to him or to Jose Ramon Moreno. Jose Ramon clarified that while all information is welcomed for the FEPA Website, we keep the magazine FEPA News

for the information that is important in opinion of the National Federations. So that FEPA News had a register in paper for the future of all relevant philatelic events hold in all European Federations.

Bojan Bracic asked all delegates to acknowledge receipt of his e-mail messages to confirm that the information he send is reached by the National Federations.

Giancarlo Morolli announced a project involving also the FEPA website at building a database of new philatelic publications. He also informed about the improvement of procedures of the expert team and the plans to have this subject well organized thanks to the efforts of James van der Linden and his fellow experts

The FIP Congress in Bucharest accepted experimental regulations for One Frame Class, but some National Federations ignore them. Jussi Tuori, responsible for the One Frame Class within the FIP Board explained, that the One Frame Class will disappear if the Congress in Lisbon accepts the FIP Board proposal that the exhibits with only one frame will belong to their respective class. Francis Kiddle proposed that such proposals should be sent to all Federations. Also that the list of eight frames exhibits which is done by the FIP Secretary should be available to all member Federations.

6. and 7. Gerhard Kraner presented the Annual Report 2009 and the Budget 2010, explaining some of the major figures. Both documents were approved by unanimity of the Delegates, giving thanks to the FEPA Treasurer.

8. Changes of the FIP Statutes. FEPA President Jørgen Jørgensen explained that since the FIP Congress in Bucharest we have been waiting for the FIP Board to take initiatives to present a motion to change the FIP Statues. In his view there was an urgent need for change of articles 30.2 and 30.4 in the FIP Statutes which deals with the number of seats in the board and the representation of the three Continental Federations.

Philately in general would benefit if it is possible to reach a lasting agreement between all National Federations in FIP on the size of the FIP Board and the number of seats allocated to the 3 Continents. Too many resources are actually allocated towards a discussion of size, strength and "fair representation". Resources - that are much better spend in discussions with focus on development of our hobby.

Mr. Jørgensen told that shortly after his arrival to Antwerp, he was informed by Jussi Tuori and Bernard Jimenez, members of the FIP Board, that they together with Peter McCann, also member of the FIP Board, had discussed the future size and allocation of seats of the FIP Board. Ideas that likely could attract the needed 2/3 of all votes at the FIP Congress – which is the required minimum support for a motion to pass.

Motions presented by the Member Federations are to be submitted to the FIP Secretariat at least five month before the Congress – which means before 10th of May

The FIP Board can submit motions up to two month before the Congress.

The main components of the proposal were:

- 1. Increase the number of board members from 7 to 9
- 2. Allocate the seats between the continents in this way:
 One President by election amongst all Continental Federations. 1 Vice-President for each FEPA,
 FIAF, FIAP. 5 Directors: 1 for FIAF, 2 for FIAP and 2 for FEPA.
- 3. Delete article 24.2 in the FIP Statutes.

Pedro Vaz Pereira asked why those proposed changes of the FIP Statutes had not been sent in advance to the FEPA member Federations, and why was discussed a matter which was not included in the Agenda of the Congress. Jussi Tuori answered that the proposal, which may be acceptable by all Continentals was by now only a draft.

Francis Kiddle and Victor Coenen, amongst others, expressed their view that we had to be realistic taking in mind the need of two third of the FIP members Federations votes. So, even if the proposal is not the best, is better than the present situation.

Mr. Vaz Pereira did not wanted to delete the article 24.2 of the FIP Statutes, according which it was necessary that the FEPA candidates were those supported by the FEPA Congress. Also he thought that the increase should be of only one member to reach 8, and that this member should be for FEPA as it was the "Gentlemen's agreement" in effect until the 2008 FIP Congress in Bucharest.

After a discussion where many of the delegates expressed their views, 22 Federations supported the proposed idea, while 11 were against.

President Jørgen Jørgensen asked that the ideas were converted into a formal motion by two or three European Federations. Then they would be distributed to all European Federations for comments, also the Motion would be discussed with member federations of FIAP and FIAF and with FIP Board, after what the final Motion would be submitted to FIP Secretariat before the deadline of the 10th of May.

9. FEPA Candidates to the FIP Board. Only one candidature for new FIP President and one for FIP Director came in due time.

The candidates were:

Even if there were only one candidate for each position, according to FEPA custom was held a voting by secret ballot. Mr. Vaz Pereira received 24 votes supporting his candidacy to FIP President. Mr. Rangos received 34 votes supporting his candidacy to FIP Director.

10. Exhibitions. Francis Kiddle reported about the preparations of London 2010. Pedro Vaz Pereira had a talk about the good progress of Portugal 2010 in Lisbon next October despite the budget problems which recently arise.

Boncho Bonev informed about Balkanfla exhibition which will be held also in October 2010 in Plovdiv, Bulgaria. After his request, the FEPA Congress granted support to this exhibition.

Jos Wolf confirmed that Philalux 2010 has been postponed to 2011.

Piero Macrelli was pleased to tell the Congress about the outstanding financial results of Italia 2009. Vit Vanicek informed about the intention of the Czech Federation of organize an exhibition in Brno, Czech Republic in 2013. If this project goes ahead they will ask for holding the FEPA Congress.

11. Next FEPA Congress. Ivan Librich in the name of the Croatian Philatelic Association invited FEPA to hold its next Congress in Opatija, touristic centre along the Adriatic coast, during the Alps-Adriatic Philately exhibition which will take place there from 14th to 17th April 2011. Mr. Libric show a beautiful presentation of the region, the city and the official hotel. It was accepted unanimously that the 2011 FEPA Congress will be in Opatija.

The meeting was prepared in about 10 weeks, hence it could be neither exhaustive nor final: but the appreciation of the attendees has clearly shown that these initiatives are valuable and, in the view of the FEPA Board, they shall be

repeated in the future covering the subject of top interest for the philatelic community.

Our philatelists have always considered stamps as are the prepayment of a fee for postal services and their issue has been authorised by a Governmental decree, as they have represented, from their very beginning, a sign of the State sovereignty.. Sometimes there are (or were) limits like the prohibition of devoted issues to living persons (with the obvious exception of the Head of State), and or to foreigners, or to celebrate only "round" anniversaries.

Exhibitors have been educated to comply with the original GREX definition: "Appropriate philatelic material is that which, for the purpose of transmitting mail or other postal communications, has been issued, intended for issue, or produced in the preparation for issue, used, or treated as valid for postage by governmental, local or private postal agencies, or by other duly commissioned or empowered authorities...".

Today is a common fact that postal companies, private, seek either public or business opportunities for additional revenue on top of their core business, namely the carrying of mail. Browsing through these companies it is possible to buy Personalized stamps, Individual Stamps, Smilers, Prestige booklets, Regional stamps and booklets, Private post commemorative and pictorial ("thematic") issues, Issues of Printing Companies sold through postal channels and recognized as valid for postage, Photostamps. Electronic stamps, Smart Stamps, end some more...

Many of these products are launched on the basis of market research, without any other need or requirement (or decree); the driving concept of their strategies is based on revenue and profit, hence they tend to issue what the customers want. If sales of a certain issue do not meet the objective the production is stopped; if it exceeds it, consideration will be given to adding new items to the series or issuing similar subject. Furthermore the denomination of these stamps may be lower than the price paid.

The customer set for these items is composed of collectors, non necessarily the current philatelists. Most of them apply other criteria than those that have guided philatelists over the many decades of our hobby. The success of similar initiatives for objects manufactured as declared imitations of the originals attest that collectors like items produced just to meet their interest and provide them pleasure,

irrespective if they are original or, in our specific case, if they have a full postal significance.

A number of mail carriers operate on a multinational basis, but also national based companies can exploit globalisation via the Internet. It works as marketing channel but also can be used for getting feedbacks, in addition to sales statistics, to assess the customer's preferences and calibrate the new issues on the same: "tell us what you want next".

In the future philatelic organisations are asked to answer these questions:

- Which is/will be the impact on our philatelists?
- Any chance for a synergic effect?
- If yes, which are the goals and the requirements? Or Is our approach too traditional, perhaps obsolete?

She pointed out that the strategy of the Austrian Post is summarized by the word "Innovation". Innovative approaches have been a must in many areas of the human activities and philately cannot ignore it. The future of postal stamps has been strongly jeopardized by products of the new technologies, from email messages to electronic frankings, but the Austrian Post has shown that appropriate technologies can be exploited to make innovative stamps able to regain the interest of the public. Austrian technological issues encompass stamps with Swarovski Crystals, ground Meteorite, Embroidery with from to Petit Point, and len-ticular Technology. Furthermore the joint issue with Israel devoted to Simon Wiesenthal presents his portrait in a frame in the form of the Star of David, applied using a brand new printing technique based on laser etching and lacing technology as well as laser philatelic perforation.

Since March 2007 the Slovenian Post has been producing personalized stamps: the latest figures show a total exceeding 3000 motifs. From one side the pressure to Stamp Advisory Committee, responsible for deciding upon the new issues, were at least 250 per year, and from the other personalized stamps could have generated additional revenue for the Post. Hence, it has been allowed to everyone to order personalised stamp, proposing his own motif, provided it respects the laws, the moral, the privacy. The personal motif is inserted in a frame, chosen among those (88 different) approved by Stamp Advisory Committee. The minimum order quantity is just one sheet, composed of 20 stamps.

The reaction of Philatelists to this initiative has been a mixed one: some groups do not like this product and they reject the word "stamps", considering them as "labels", and this is also the opinion of other philatelists who are against selfadhesive stamps. On the contrary other philatelists have started collecting personalised stamps trying to get as many as possible. Some of them have ordered stamps depicting motifs for their thematic collection that cannot be found on other philatelic items; other individuals or societies have created maximum cards from them. Some philatelic clubs and societies have started using these stamps for marking special events and anniversaries. There have been initiatives for putting create private catalogues on the web.

The Slovenian Post has also introduced the Personalised Picture Postcards, with free chosen motifs on the back side.

Picture Postcards are issued by GAMA Ltd which collaborates with Post of Slovenia in this project and takes care of the delivery of these items**t** to

the addressees indicated by the customer, whose addresses are printed on the front side. On the same side there are the inscriptions "POSTAGE PAID at 1234 Xyzxyz (name of the post office)".

He explained that nowadays many postal authorities did not just issue a set of stamps but using the basic set as a foundation, by varying products (eg miniature sheet, deluxe imperfs, prestige booklets, postcards etc) they increased the potential value of each issue. He quoted that a typical issue of British commemoratives had a face value of £2, yet collecting all the variants supplied by Royal Mail (including Smilers), meant a collector had to pay £50 per issue. 12 issues per year (plus extras) equates to over £1,000.

Looking at the investment into philately within Europe, he analysed what is happening within the seven European Foundations (Be, Ch, Dk, Fr, Ge, GB, NI). Three of them (Be, Fr, Ge) get major support from their post offices and obtain significant finance through issues of stamps, and through this, they can finance and promote philately. However, four countries (Ch, Dk, GB, NI) get zero funding from their national post offices. In each of these four countries, philately and new issues are simply aimed at maximising post office profit and there is no investment for the future, a classic 'milk cow' situation.

Discussion

A very wide discussion followed these presentations, and the key concepts recorded were:

The Postal administration should make sure that stamps are on sale at the counters as required: it was regretted that in many countries the offer is declining and that postal clerks tend to use machine generated labels or the like for franking letters.

Philatelists should understand that most of these stamps (or "labels" as other prefer to name them) have a postal validity, so they are perfectly acceptable in the exhibits, as long as there are justified within the overall concept of the exhibit).

No rarity can be claimed based on the fact that same issues (namely personalized stamps) have been printed in a very small quantity... ad they have been made on a personal order, to please the customer!

Philatelic organisations should look to the new collectors as a potential and a resource rather as philatelists of a lower class. Who can exclude that some of them could be later become philatelist in the current sense of this word?

Electronic stamps, Smart Stamps, end some more...

Many of these products are launched on the basis of market research, without any other need or requirement (or decree); the driving concept of their strategies is based on revenue and profit, hence they tend to issue what the customers want. If sales of a certain issue do not meet the objective the production is stopped; if it exceeds it, consideration will be given to adding new items to the series or issuing similar subject. Furthermore the denomination of these stamps may be lower than the price paid.

The customer set for these items is composed of collectors, non necessarily the current philatelists. Most of them apply other criteria than those that have guided philatelists over the many decades of our hobby. The success of similar initiatives for objects manufactured as declared imitations of the originals attest that collectors like items produced just to meet their interest and provide them pleasure,

irrespective if they are original or, in our specific case, if they have a full postal significance.

A number of mail carriers operate on a multinational basis, but also national based companies can exploit globalisation via the Internet. It works as marketing channel but also can be used for getting feedbacks, in addition to sales statistics, to assess the customer's preferences and calibrate the new issues on the same: "tell us what you want next".

In the future philatelic organisations are asked to answer these questions:

- Which is/will be the impact on our philatelists?
- Any chance for a synergic effect?
- If yes, which are the goals and the requirements? Or Is our approach too traditional, perhaps obsolete?

She pointed out that the strategy of the Austrian Post is summarized by the word "Innovation". Innovative approaches have been a must in many areas of the human activities and philately cannot ignore it. The future of postal stamps has been strongly jeopardized by products of the new technologies, from email messages to electronic frankings, but the Austrian Post has shown that appropriate technologies can be exploited to make innovative stamps able to regain the interest of the public. Austrian technological issues encompass stamps with Swarovski Crystals, ground Meteorite, Embroidery with from to Petit Point, and len-ticular Technology. Furthermore the joint issue with Israel devoted to Simon Wiesenthal presents his portrait in a frame in the form of the Star of David, applied using a brand new printing technique based on laser etching and lacing technology as well as laser philatelic perforation.

Austrian issues do not necessarily address the traditional customer set composed of current collectors, as they have been appealing for the everyday clients of the post offices.

Since March 2007 the Slovenian Post has been producing personalized stamps: the latest figures show a total exceeding 3000 motifs. From one side the pressure to Stamp Advisory Committee, responsible for deciding upon the new issues, were at least 250 per year, and from the other personalized stamps could have generated additional revenue for the Post. Hence, it has been allowed to everyone to order personalised stamp, proposing his own motif, provided it respects the laws, the moral, the privacy. The personal motif is inserted in a frame, chosen among those (88 different) approved by Stamp Advisory Committee. The minimum order quantity is just one sheet, composed of 20 stamps.

The reaction of Philatelists to this initiative has been a mixed one: some groups do not like this product and they reject the word "stamps", considering them as "labels", and this is also the opinion of other philatelists who are against selfadhesive stamps. On the contrary other philatelists have started collecting personalised stamps trying to get as many as possible. Some of them have ordered stamps depicting motifs for their thematic collection that cannot be found on other philatelic items; other individuals or societies have created maximum cards from them. Some philatelic clubs and societies have started using these stamps for marking special events and anniversaries. There have been initiatives for putting create private catalogues on the web.

The Slovenian Post has also introduced the Personalised Picture Postcards, with free chosen motifs on the back side.

Picture Postcards are issued by GAMA Ltd which collaborates with Post of Slovenia in this project and takes care of the delivery of these items**t** to

the addressees indicated by the customer, whose addresses are printed on the front side. On the same side there are the inscriptions "POSTAGE PAID at 1234 Xyzxyz (name of the post office)".

He explained that nowadays many postal authorities did not just issue a set of stamps but using the basic set as a foundation, by varying products (eg miniature sheet, deluxe imperfs, prestige booklets, postcards etc) they increased the potential value of each issue. He quoted that a typical issue of British commemoratives had a face value of £2, yet collecting all the variants supplied by Royal Mail (including Smilers), meant a collector had to pay £50 per issue. 12 issues per year (plus extras) equates to over £1,000.

Looking at the investment into philately within Europe, he analysed what is happening within the seven European Foundations (Be, Ch, Dk, Fr, Ge, GB, NI). Three of them (Be, Fr, Ge) get major support from their post offices and obtain significant finance through issues of stamps, and through this, they can finance and promote philately. However, four countries (Ch, Dk, GB, NI) get zero funding from their national post offices. In each of these four countries, philately and new issues are simply aimed at maximising post office profit and there is no investment for the future, a classic 'milk cow' situation.

Discussion

A very wide discussion followed these presentations, and the key concepts recorded were:

The Postal administration should make sure that stamps are on sale at the counters as required: it was regretted that in many countries the offer is declining and that postal clerks tend to use machine generated labels or the like for franking letters.

Philatelists should understand that most of these stamps (or "labels" as other prefer to name them) have a postal validity, so they are perfectly acceptable in the exhibits, as long as there are justified within the overall concept of the exhibit).

No rarity can be claimed based on the fact that same issues (namely personalized stamps) have been printed in a very small quantity... ad they have been made on a personal order, to please the customer!

Philatelic organisations should look to the new collectors as a potential and a resource rather as philatelists of a lower class. Who can exclude that some of them could be later become philatelist in the current sense of this word?

The London experiment worked

London was the focus of attention of the philatelic world during May. The reason is that, as happens every ten years, the capital hosted an International Stamp Exhibition.

However, this time London 2010 was innovative in many ways. **The venue, the Business Design Centre** in Islington, proved ideal, allowing




The Business Design Centre in Islington

for an exhibition in a compact area, but Nevertheless easily accommodating over 150 standholders and 1,250 frames of exhibits.

A long queue had already formed by the time the doors opened on most days, especially on the opening day, Saturday, 8 May. Every day the attendance was more than 5,000, resulting in total attendance over the eight days of almost 50,000. There were very few moments when stand holders were not dealing with customers, and there was a constant stream of collectors at the impressive Royal Mail stand.



Among the outstanding items to be seen was the **Sweden 3 Skilling** error of color, in yellow-orange instead of green, thought to be the world's most expensive stamp.

Also on view was the world largest envelope, as confirmed by the Guinness Books of Records, sent by Stanley Gibbons to Brian Trotter, Chairman of the exhibition.

However, the main focus of attention centered on the fact that this was 'two exhibitions in one' with the exhibits being changed over halfway through the event. Many were skeptical as to whether it could be achieved: it went ahead flawlessly. Thanks to a dedicated team of hardworking volunteers it took just six hours to dismount the first half exhibits from the display frames and replace them all with fresh exhibits.

It fact, one of the keynotes of the exhibition was the amount of work undertaken so willingly by well over one hundred volunteers, working not only throughout the exhibition, but for days, weeks and months beforehand. Without their help, it would not have happened. The exhibition had to operate on a very controlled budget, and thus the concept of having 1,250 frames, but by changing the exhibits halfway, there were 2,500 frames of material on display. The exhibition had to pay for itself, the stand holders and exhibitors

naturally contributing. However, many individuals and organisations gave generously to make it happen, with particularly significant donations from the British Philatelic Trust and Royal Mail.

Brian Trotter, Chairman of London 2010 International Stamp Exhibition, commented, 'I must pay tribute to all those who worked so efficiently and effectively over months and years to ensure the exhibition was a great success. All worked together magnificently as a team. I am sure that with increasing financial pressures on exhibitions across the world, many will be encouraged by the success of our experiment to have two exhibitions in one. It worked, and I can see that many others will now follow our lead.

Nordia 2010 in Sweden

Back in 1966 Finland hosted the very first Nordia exhibition – since then the Nordic Countries: Denmark, Finland, Iceland, Norway and Sweden have in tour hosted the Nordia exhibitions.

In the last 20 years there have – with a few exceptions - been a Nordia each year.

Sweden hosted their first Nordia in 1980 in Malmoe and then each fifth year Lund, Malmoe, Stockholm and Gothenburg.



This year Nordia 2010 were organized in Boraas from 28th to 30th May. Boraas is with its app. 100.000 inhabitants situated half an hour east of Gothenburg.

The exhibition had 850 frames covering all classes, 25 dealers and 9 Postal administrations.

Today the workshop has been renovated respecting the origin of the location which gave the exhibition hall a special rustic touch – that made the impression different from a "standard" exhibition hall.

Organizers of an exhibition normally rank the number of visitors as one of the important success factors. Nordia 2010 clearly demonstrates that it is possible to organize an exhibition and attract visitors even it is not organized in one of the main cities.





Romanian Philatelic Federation Towards its 110th anniversary

Next year the Romanian Philatelic Federation will commemorate its 110 years of existence.

On January 1/13, 1881 has been published the first philatelic magazine in Romania, suggestively named "TIMBROPHILO".

In April 1891 has been established in Bucharest, under a temporary name, "The Romanian Stamps Society"

And at May 6, 1891 has been organized the very first philatelic exhibition in Romania, having a private status, in the house of President Dimitrie C. Butculescu in Bucharest (the present Lido Casino).

In the meeting of November 26/December 10 1891, the society changed its name into "Romanian Philatelic Society", being adopted also the club bylaws.

After the celebration in 2008 the World Philatelic Exhibition Efiro 2008 to commemorate 150 years since the first Romanian stamps have been issued, the Romanian Federation is facing another important milestone.

All these events organized by R.P.S. are trying to promote historical, cultural and moral values of Romanian people through stamps.

Centenary for Aberdeen Philatelic Society 1910-2010

The Society came into being as the Aberdeen and North of Scotland Philatelic Society on 30

March 1910 in a solicitor's office in Union Street, where meetings were held in the first year.

The membership grew rapíd1y necessitating new venues. For a short period in the 1930s the Society even leased its own rooms.

Looking back over a century of meetings, the annual syllabus in the early years often included topics with an educational flavor, such as how to arrange your collection.

By the late 1920s one-country displays were increasingly favored. Over the years 130 different countries have been named in the syllabus, most frequently Great Britain, followed by Canada.

In the early years public exhibitions were quite frequently held in Aberdeen and continued occasionally until the 1970s. They were sometimes accompanied by substantial brochures which must now rank among the rarities of philatelic literature.

A library was initiated in the very first year, but by 1937 problems of storage were such that it was donated to Aberdeen Public Library, whence it was retrieved in 1999, so that members now enjoy a library which is a historic archive in its own right. A forgery collection of similar vintage is also maintained.

Membership has fluctuated over the decades from 27 in the first year to 310 in 1951, declining to the current stable state of about 70. The exchange packet was an attraction in the past, particularly among country members and is still available at evening meetings.

Distinguished 1 names from the past include PJ Anderson RIDP, described by Melville e as "the biographer of philately", George Mi1ne, a student of heraldry in philately, and WSE Stephen of Austrian Pos Abroad fame.

Several of the current members are also active in research and publication.



SAMIR AMIN FIKRY

(14 September 1932 – 5 February 2010)

Philately has lost a Gentleman

Samir Amin Fikry was born in Cairo in September 1932. He obtained a B.Sc. in Architecture at Cairo University and continued to practice as an architect decorator for the rest of his life.

Samir started the hobby at the age of 18. In 1980, he completed a period of fifty years (1930-1980) mint stamps, of U.K., France, W. Germany, Switzerland, Egypt and Sudan. After his wonderful family, Samir first love was his country. And he applied this to Philately. He

visited Philexfrance 1982, where he found that the Grand Prix d'Honneur was received by a Swiss (E. Antonini) for his Egyptian collection. From that day, he decided to shift his attention entirely to collections of Egyptian Philately, and started to build his ten international exhibits which cover all issues of Egyptian philately till 1960 in more than 1000 sheets.

In 1993, Samir Fikry accepted using his "Nile" exhibit as a base for printing the FIP Guide to Exhibiting and Judging Traditional and Postal History Exhibits from which benefited collectors from many countries. His book "The Postal History of Egypt to 1900, was published by The Royal Philatelic Society of London in 1995. Also wrote the "Egyptian Rarities Prior to the Twentieth Century" in serial form in The London Philatelist from January 1994 to February 1995.

He was considered the leading philatelist of his country and had contributed to the recognition of Egyptian philately worldwide. Due to his efforts Egypt entered into FEPA.

He was the chairman of the O.C. and president of the jury at the International Exhibition held in Cairo in October 1991, where he received the Ibrahim Chafter special medal from the Philatelic Society of Egypt.

Collector of Postal History, Traditional and Aerophilately, he won three FIP Grand Prix with his exhibits "The Nile Collection" and "Postal History of Egypt", at Indipex In New Delhi, New Zealand, and at Espana 2004, in Valencia. Samir was an active member of L'Academie Europeenne de Philatelie, The Belgian Philatelic Academy, The Club de Monte Carlo, The Royal Philatelic Society, London, The Collectors Club of New York, The Philatelic Congress of India, and The Philatelic Society of Egypt, Cairo amongst others. He was elected member of the FEPA Board at the 1997 FEPA Congress held in Oslo, Norway. He served at the FEPA Board until 2001. Vice President and member of the Board of the Egyptian Philatelic Society for the period 1988-1996. FIP Jury and member in many international exhibitions etc. etc.

Samir was always nice and helpful. Respectfully to all ways of thinking and beliefs, he was a great philatelist but more important he was a collector of friends. His memory will remains in those of us who were lucky to know him. Our warmest condolences to his beloved wife Jeanne and to the rest of his family


Yves was a long time philatelist, specialist of the postal history of the Dordogne region and an international gold awarded exhibitor with his exhibit about the French Second Empire stamps.

New RDP's to sign Roll

The Roll of Distinguished Philatelists was established in 1921 by the Philatelic Congress of Great Britain with the approval of His Majesty King George V who was the first Signatory. An invitation to sign the Roll is regarded as the world's pre-eminent philatelic honor.

Not including the newly elected RDPs, 346 philatelists from 40 countries have achieved this distinction. There are at present 71 Signatories from 24 countries including fourteen from Great Britain, ten from the USA, five from Italy, four from Germany, and three from Switzerland.

At a recent meeting of the Board of Election, comprising Patrick Pearson (Chairman), Tomas Bjäringer, Christopher Harman, Alan Huggins, Rolf-Dieter Jaretzky, Jane Moubray and Robert Odenweller, with Christopher King, Secretary to the Board in attendance, the members unanimously decided to ask the following 6 well known philatelists sign the Roll.



Dutch-born **Cornelis (Kees) Adema** resides in the USA, and his collections and writings are principally devoted to Dutch postal history. His first book, *The First Postage Dues, Holland's 3S Markings 1667-1811*, is considered the definitive study of early Dutch markings.

He has received various awards for his writings and research: in The Netherlands the prestigious Professor van der Willigen award (2003) and the Edwin Koenig Medal (2006) awarded each lustrum. In Germany he received the Professor Dr Carlrichard Bruhl award (2003) and in the USA the 2009 Luff Award.



Dr Hugo Goeggel is the leading philatelic expert in Colombia and Latin America having exhibited both classic issues and airmails with distinction. His exhibits include a gold medal for 'Colombia: Pre-adhesive', large gold medals for 'Classic Brazil - The First Issue of 1843', 'Classic Ecuador: the first issue 1865/72', and 'Colombia, Colonial Postal History'. 'Classic Colombia - The First four Issues 1859-1862' and 'Colombia - Development of air mail (1919-1928)', are now exhibited in the Championship Class.

Hugo Goeggel has also served in a number of important positions, notably as President of the Inter-American Philatelic Federation from 1997-2008 and as President of the Colombian Philatelic Federation, for which he is currently serving a second term.



Dr Wolf Hess will be well known to international exhibitors. He has served at a number of FIP sponsored international exhibitions and is a team leader for the postal history class. He has served as Jury President and Secretary at national exhibitions. He has also participated as exhibitor having formed gold medal exhibits in traditional, postal history, postal stationery and thematic classes, a remarkably wide range of classes.

Wolf has done research in the thematic and postal history fields and also written two books *Postgeschichte London, Part 1: Allgemeine Staatspost - inlandpost bis zum 10 Januar 1840- London postal history from 10 January 1840, and part 2: Die Ortspost 1680-1840 London pre-stamp cancellations* (1994), besides many articles on various subjects on thematic and postal history.



The name of **Dr Giancarlo Morolli** and thematic philately is almost synonymous; he has provided leadership in the development of the subject as member, and from 1977-2004 as President of the FIP Thematic Commission, achieving universal acceptance of the concept of thematic philately. For this he was awarded the FIP Medal of Service in 2004.

In addition to the Thematic Commission Giancarlo has served in a number of senior positions, he is currently Vice President of the AIJP, a director of FEPA, and national representative for Italy to the Royal Philatelic Society London. In the exhibition field he has served as a juror internationally since 1972 and was President of the Jury at Genova '92, Italia '98 and Italia 2009, playing a key role in the organisation of these exhibitions. For his services he has received a number of awards, most recently the FEPA 2006 Medal for exceptional service to organised philately.



Wade Saadi has formed and exhibited a number of major studies of US classics. He obtained a gold medal for his study of US issues from 1851 to 1868 at the St Petersburg exhibition in 2007 and has also exhibited a study of varieties of the 1847 issue at Pacific 1997. In 2003 he presented the Sir Daniel Cooper lecture the Royal Philatelic Society London on the first issues of the United States.

Wade has also contributed very significantly in national organisations, he has recently been re-elected President of the American Philatelic Society, is Vice Chairman of the Council of Philatelists of the Smithsonian National Postal Museum, is President of the US Philatelic Classics Society, and was President of the Collector's Club 2005-2008. He is also President of the Organising Committee for the World Stamp Show - New York 2016.



Brian Trotter currently will be familiar to British philatelists as the indefatigable Chairman of the London 2010 International Stamp Exhibition committee, which he has chaired since 2004. He has also served as Chairman of the British Philatelic Trust since 2006.

He has been awarded large gold medals for the 'Revenue stamps of South Africa', the 'Revenue stamps of Southern Rhodesia' and the 'King's Head postal stationery of South Africa'. He has also written extensively on these issues, notably *The Edwardian Stamps of the South African Colonies* published in 2004, covering all postage and revenue issues. Brian has also contributed significantly to organised philately. He served as Secretary of the Royal Philatelic Society London and is currently Vice President. He chairs the ABPS Exhibition Committee and is an accredited FIP international judge, as well as an accredited national judge for both South Africa and the UK.

The Signing Ceremony will take place on Friday 23rd July at Leamington Spa Town Hall during the 2010 Philatelic Congress of Great Britain, which will be held in Kenilworth from 22nd - 25th July.

Exponet – After 5 years of existence.

EXPONET is a virtual international philatelic exhibition supported by the Union of Czech Philatelists and endorsed by Minister of Culture of the Czech Republic.

It includes permanent, non-competitive presenting and exhibiting philatelic exhibits of all FIP competitive and experimental classes. The virtual exhibition was launched in the Czech Republic five years ago, in 2004.

The inventors and pioneers of EXPONET were Messrs. Břetislav Janík and his colleague Milan Černík. EXPONET is widely opened to stamp collectors from all over the world for display of mainly philatelic collections and exhibits and for their on-line study.

The internet address is as follows: www.exponet.info, while postal and e-mail addresses are EXPONET o.p.s., P.O.Box 409, CZ-111 21 Praha 1, Czech Republic, or icernik@volny.cz

After five years, EXPONET offers 600 exhibits from 47 countries in 3,274 frames. This number of frames may be compared with the size (extent) of the great World Philatelic Exhibition WASHINGTON 2006. The number of visits reaches up to 800 different visitors from about 146 countries of the world per day. So this "Czech invention" became one of the largest virtual non competitive philatelic exhibitions on our "green planet".

I will always keep in my mind the FIP Board meeting during the SINGAPORE World Stamp

Championship 2004. It was there that I had the first chance to inform the FIP Board members about this original and certainly very useful project. Philatelists in Australia were the very first to accept the idea. It is my pleasure to mention the iNAPE and its ASIA PACIFIC EXHIBITOR in which EXPONET has been almost regularly promoted for more than three or four years. I would like to express my gratitude to the Editor of this Australian periodical. Not to forget, an EXPONET booth at PRAGA 2008 World Stamp Exhibition with fifteen computers at free disposal to anybody interested in it was also a success.

Launching PhilaPedia.com

During London 2010 the first online Postal history Encyclopedia/Catalog, PhilaPedia were launched.

The organization with Moti Kremener, Isarael as manager has in a press release presented the project as follows:

Philapedia is a multilingual, web-based, free-content encyclopedia project for postal history collectors. The name PhilaPedia is a portmanteau of two words "Philatelic and Encyclopedia".

Philapedia project provides historical, philatelic, price valuation and other philatelic information regarding postal history items from all over the world.

The advanced postal history collector has gained his information throughout the years of collecting stamps; however, to the beginner and upcoming collector it is a difficult task.

How did we come about to develop Philapedia site

The idea evolved from my needs as a postal history collector spending a great deal of time and effort looking for information about various items in my collection; hence, as the old English proverb goes: "Necessity is the mother of invention".

Through my experience of operating www.Stampcircuit.com site, I have become aware that the solution lies in the internet and with the media/pedia technology.



The most important objective of this project is to introduce this hobby to new collectors. As one philatelist told me in this year's London 2010 World Exhibition, "since the young generation will inherit our collections, we must make sure they inherit our knowledge as well....".

Philapedia is supported by the FIP Commission for Postal History as well as specialist Postal History Societies and work groups.

Background

As a collector of "Postal History" I have always been looking for a central source to find historical, philatelic and valuation information regarding an item, relying on numerous philatelic literatures, auction catalogs and becoming familiar with relevant collection to gather information about an item.


This open source technology is the basis for the wikipedia.com web site, the largest encyclopedia to date.

Conclusion

Higlights from the 2009 report.

The Commission's Bureau

The Commission's Bureau continued to work in its original composition as elected in 2008.

<u>The Commission Bureau meeting</u> took place on October 22, 2009 during the Italia 2009 exhibition

The participants were acquainted with the Commission's activities in Europe and the Americas and the progress on the preparation of the final version of the Streamlined Seminar#2 (SS2).

A list of qualified presenters for FIP Postal History judging seminars and for FIP general and exhibiting seminars in Postal History was presented, discussed and approved. Twenty nine individuals were approved as presenters of general and exhibiting seminars and eight as presenters of judging seminars.

With regard to the Bureau information policy, it was decided that only final decisions of the Bureau may be communicated to outside parties.

The discussion regarding improvement of SREV and the Guidelines was postponed. The process of accreditation/cross-accreditation of judges was explained by Paulo Comelli.

The Commission's Delegates

In January 2009 Mr. Rui Pires Mendes was confirmed as a new delegate of the Portuguese federation. The Secretary of FEFILCO confirmed Dr. Hugo Goeggel as the Columbian delegate on May 27, 2009. On September 8, 2009, we lost the Peruvian delegate, Mr. Aldo Salvatteci Amador (President of the Peruvian Federation) who passed away. A replacement has not yet been appointed.

As of December 31, 2009, there were 88 members of the FIP including 2 provisional

members; only 74 appointed as delegates to our Commission.

The continental composition of our Commission is as follows:

FEPA (Europe) - 38 (40) delegates

FIAF (Americas) - 13 (16) delegates

FIAP (Asia, Africa & Australia) – 23 (32) delegates

The numbers in parentheses reflect the number of FIP members located in the areas of continental federations.

The Commission's Activities

Over the course of the last year, the Commission's efforts were focused on the preparation of seminars. In late 2008, each member of the Commission was assigned a specific subject of postal history to work on. The decision was made to consolidate those assignments and the seminar initially prepared by Dr. Andrew Cheung, *How to Win a Gold Medal in Postal History*, in the form of three streamlined seminars:

SS1 "The new SREVs and Guidelines for Postal History Class",

SS2 "The Judging Criteria for Postal History", and

SS3 "How to Win a Gold Medal in Postal History".

Ms. Patricia Stilwell-Walker and W. Danforth Walker took upon themselves the task of preparing drafts of the above mentioned seminars based on our input.

Drafts were distributed at the end of January 31, 2009 to the Commission's members for their feedback. In May 2009, final versions of SS1 and SS3 in two formats were placed on the Commission's website.

SS1 in PDF format requires 12.7 mb and in PowerPoint compressed ZIP file – 186 kb.

News about FIP Commissions

SS3 in PDF format requires 16.9 mb and in PowerPoint compressed ZIP file – 427 kb.

The Commission's Website

The Commission's website has been updated regularly by our Webmaster Malcolm Groom. Below are some highlights of additions which took place in 2009:

- Translations of SREV and Guidelines into: French, German, Spanish, Danish, Portuguese, Hungarian and Chinese.
- 2) The Question and Answer section where questions addressed to the Commission are published along with answers. This section is coordinated by our Chairman after consulting all the Bureau members.
- 3) Streamlined Seminars SS1 and SS3 are published in two formats.
- 4) Class 2C Exhibits.

The Commission is looking for examples of modern period exhibits and One Frame postal history exhibits to be published on our website. Our webmaster wishes to receive more items for our site "cover watch" and references to the main postal history literature in each area.

TREATMENT OF POSTAL STATIONERY EXHIBITS – PART II

Following up on the article in newsletter #2 (Jan 2009) I have made some new observations on the traditional versus postal historic oriented postal stationery exhibits.

I was participating in the FEPA exhibition in Bulgaria in May 2009 as a commissioner, and here the highest awarded postal stationery was awarded large gold and nominated for the international grand prix. The interesting thing for

me was that this exhibit had mostly a postal historic approach to the treatment of the exhibit: On 90% of the items the descriptions only related to the usages and which cities the items had been sent from and to – with small maps illustrating the routes used.

There was also some traditional treatment – 6 pages with essays and a few pages informing about the numbers printed and a few colour varieties. The material in the exhibit was from a postal historic point of view fantastic, and this is probably why the jury nominated it for the grand prix. It could not have been because of the treatment seen from a traditional postal stationery point of view.

This is an excellent example for me that jurors can get so impressed with great usages of the material that we forget that postal stationery exhibits should have a good solid traditional treatment before adding items of postal historic interest.

Or.... are we seeing a development in the postal stationery exhibits that we should follow and support?

This would mean that we should be allowing postal stationery exhibits that have a postal history focus, but with use of postal stationery only. I would like you to comment on this — I have seen several of the "postal historic" postal stationery exhibits but when we now start nominating them for grand prix I find it very important that we in the commission decide if we want to see them or not in the postal stationery class.

REVISION OF GUIDELINES

The Postal Stationery Commission Bureau has decided to start up a process of reviewing and revising our guidelines for evaluation of postal stationery exhibits.

The regulations and guidelines were approved by the 61st F.I.P. Congress in Granada on the 4th and 5th May 1992 and come into force on 1st January 1995. (See the regulations and guidelines on page 26)

Since then hundreds of exhibits have been evaluated and we believe that it is now time to gather the experiences we have with the current guidelines and start up a process with an update of them.

We mainly focus on a revision of the guidelines and not the regulations, because we believe that the need for an update is mostly related to the guidelines. However if it turns out that the regulations need an update we are open to this as well.

The process will be that we ask all delegates to send suggestions for updates/changes to the secretary before 1 August 2010. This means that you have six months to get input from the PS jurors in your country before sending it to the secretary. Then we will get an overview of the suggestions at the commission meeting in Lisbon in October 2010 and discuss possible changes. After the commission meeting our Chairman has formed a Committee which will work on the wordings. The Committee consists of: Raymond Todd, Stephen Schumann, Lars Engelbrecht and Ross Towle. A timeline for

the next steps could be: Presentation and further discussion at the commission meeting in 2012 and approval at the FIP congress in 2014.

We believe that it is important to take the time we need to make a well worked through update instead of rushing it through, and as a first step we – as mentioned – would like your input

FIP Congress 2010

In this moment a little less than $3\frac{1}{2}$ month before the FIP Congress in Lisbon - to my knowledge the Congress will take place on Sunday 10^{th} October, but a very few outside the FIP Board have an overview over which important topics the Congress will be asked to discuss and take decisions.

In accordance with article 20.2 in the Statues the notice of convocation shall be send to all members no less than three month before the opening date of the Congress.

Motions from members must be submitted at least five months before the Congress – and motions submitted by the board can wait until two month prior to the Congress.

Taking into account that we have the holiday season in front of us the National Federations will have very little time to prepare for the Congress in the beginning of October.

I will request the new FIP Board to prepare for the Congress in 2012 a revised set of Statutes with all these individually seen unimportant changes to the actual set of Statutes.

What are more important than changes to the statutes are the process and the dialog between FIP Board and the National Federations between the Congresses. Except for the elections at the Congress all other matters ought to have passed a "filter" of local and continental discussions aimed to find the best possible way forward.

If the Board wants the needed support and input from the member federations it is necessary that the member federations are informed and involved in time. The Congress doesn't leave time for long spontaneous discussions.

Each time we pass a Congress without any major decisions that focuses on bringing our hobby forward – we have lost two years!

The agenda for the Lisbon Congress

At the FIP Congresses in 2006 and 2008 a substantial part of the time were allocated towards changes in the statutes – with special focus on "a fair balance" between the Continental Federations. I am afraid that the same will happen again in Lisbon.

The members have submitted a number of motions to the Board all based on an subjective understanding of what "a fair balance" is.

To pass – a motion need support from 2/3 of all Federations present or represented at the Congress.

To me it is important that the new board are able to work together and create results for the benefit of the international Philately without specific focus on any specific Continent.

At the FEPA Congress in Antwerp we had a long discussion with exchange of many good and constructive ideas.

After the discussions the Congress - by 2/3 of the votes - asked the board to prepare a proposal based on 9 seats in the board of which all were on free election, but FIAF were guaranteed 1 VP and 1 Director, FIAP and FEPA were each guaranteed 1 VP and 2 Directors.

The proposal has been submitted individually to FIP from five FEPA Member Federations.

To me it is not important to increase the number of seats from 7 to 9 – the important thing is to supply the actual board with new members, members that isn't locked into former discussions. It will also save us many discussions if the seats are shared in advance between the Continent except the one for the President.

The Candidates to the Board

According to the statutes article 30.3 no board member can serve more the two terms of four year in the same position.

Each second year – 2010 – the President, one Vice president and one director are to be elected.

President Jos Wolf has published that he - after a number of years in the FIP Board – isn't candidate for a new period of four year.

Vice President Raymond Todd has serve the maximum of eight years as Vice President

FIP POGRAMME FOR THE NEXT 4 YEARS

Dear Mr. President.

I have taken the decision to present my candidature to FIP President, because, in my opinion, FIP needs to be improved and this only can be done if a deep reform will be implemented in our highest philatelic institution.

To implement this reform it will be necessary to proceed to a lot of different actions and to be prepared to develop a lot of work.

The dialogue and inter-action must be a constant worry between FIP and Continental and National Federations, being the only way to fulfill our objectives.

In view of the above, kindly allow me Dear President, to show my proposals for the next 4 years.

1 - Relations with Continental Federations

Continental Federations are very important in the international philatelic forum. They express very well the will of each Continent.

We must have a very strong dialogue about all things and they should be our privileged partner. With the Continental Federations we must feel all problems and wishes of the respective Continent and use this information to find a fair balance between all Continents, according their cultures, their philatelic experiences and wishes.

I will always have in consideration the Continental Federations and FIP work should be very close with them.

2 – Relations with Africa – a Continent Forgotten, a Continental Federation Promised

Africa is a Continent forgotten. We cannot <u>build</u> <u>the house by the roof!!</u>

Africa is an important Continent which must have the support of FIP. However this support must not to accept countries as FIP members, which sometimes has not any philatelic structure.

FIP Board must have two members in charge of this matter.

We must contact first the Africans Postal Administrations to check the possibilities to develop a philatelic program. We must help and promote the foundations of clubs, we must support the philatelic organization of these Africans countries, starting with a philatelic program, where the small exhibitions, can be a good way to increase the interest by philately.

But as I told, it is absolutely necessary to involve in this work the African Postal Administration and also the government of these countries.

This project it is ambitious, needs time, money and a lot of work, but it is the only way to promote the philately in Africa and this must be one of the main task of the new FIP Board.

If I am elected I will do it, having as target the development of the African philately and after a creation of a Continental Philatelic Federation of Africa.

3 - Relations with National Federations

National Federations have the power of FIP.

A FIP Board is elected by the National Federations, to promote, improve, increase and support the National Federations.

Only a team and loyal work between FIP Board and National Federations can reach our target, which is to ameliorate and improve the philatelic world.

We shall be obliged to give immediate answers to all questions raised by the National Federations, we must be ready to support the National Federations, we must be ready to discuss with the National Federations, the reform of rules, statutes, exhibitions rules all reforms to improve and organize better our world organization.

Never, but never, FIP Board can be back on back with their National Federations.

Therefore, my proposal is a frank and open dialogue hearing all of them and giving immediately support to all of them.

National Federations have the power and the task to work in the world-wide philately, they are the essence of FIP, so FIP must support them and work looking their interests and wishes, as far as possible.

4 - Magazine FLASH

It is absolutely necessary to reform the FLASH magazine, the official publication of FIP.

This magazine must be in color, A4, minimum of 72 pages, issued 3 times per year.

This magazine must have a new lay-out a new editorial philosophy where the National Federations from the three Continents, will show their work, their philatelic development, the future of the philatelic events. This will be the target of the magazine. We must have a magazine with life, where the information will be the great target, not only the past events, but also the future.

This magazine must be in charge of a Director of FIP and if I am elected FIP President ,I shall have this magazine under my charge, producing a modern, actual and professional magazine, giving to the National Federations a very pleasant and useful magazine and where

everybody will like to publish information from his country.

5 - Jurors

This is a very sensitive matter and a problem that we must try to solve.

FIP has in this moment a long list of international jurors and the great majority of them never had or will have in the future the opportunity to be FIP juror in an exhibition.

They write in their philatelic curriculum that they were FIP jurors, but many of them, in reality, never were.

On the other hand, in all FIP exhibitions FIP Board and Organizing Committee must have the supreme worry to try to nominate jurors, if not possible all, the great majority from the countries which had sent nominations to the exhibition.

It is not acceptable to nominate 5, 6, 7 jurors from the same country, which is not the organizer, and leave a lot of countries without any juror.

I can accept that FIP Board is nominating its members to be always jurors in a FIP Exhibition where will be held the FIP Congress. However, I cannot accept this in the other exhibitions. FIP Board must give also the opportunity to other countries to have jurors in the FIP exhibitions and we cannot "burn" the possibility to many countries to participate with a juror in the exhibition, only because the places are always occupied by FIP.

I cannot understand why must FIP Board be involved in this task of nomination of jurors. This bring a conflict of interests, which should not exist within FIP Board.

We need to have an independent organism to nominate jurors in FIP exhibitions.

Many other things must be thought and a reform about jurors must be introduced in FIP.

However, this must be done with all Continental and National Federations. We must seat down, we must talk, we must hear everybody about this, we must find a final draft, we must discuss and to find a resolution to this matter, but please a resolution where all countries will gain

profit. Personal interests must not be taken into

We must give the maximum privilege to all countries about jurors, taking in consideration that all are FIP members.

The jury that give the privilege to friends and political interests cannot be accepted.

If I am elected, I will present a work with my proposals to change this controversial matter of our hobby and this document must be discussed with all philatelic partners,

which are the Continental Federations and National Federations and a final document will be approved where nobody must be discriminated.

Juries with experience and new jurors must be our target.

6 - Commissioners

They are one of the most important partners of an exhibition. I can say that they are fundamental.

So FIP must turn easier their work and take care in all international exhibitions the problems with customs.

I found in the past in some international exhibitions a lot of problems and I felt many times that the organizing committee of the exhibition had not done a good work with the customs authorities.

FIP Consultant must have in consideration this point as well taking care about all points mentioned in FIP Grex, turning the life of commissioners comfortable without problems.

We cannot forget the great responsibility of a commissioner.

This must always be a worry of FIP Board, giving very clear instructions to the FIP Consultant to help and support the work of the commissioners.

Another point and if possible, it is also the possibility the air ticket to be paid to the commissioners. I know the problems that the Postal Administrations have to pay this, but now the world exhibitions are not anymore 10/11 days, which means that perhaps could be

consideration

possible to deal this with the Postal Administrations.

7 - Exhibitions

It is not possible to follow with exhibitions of 10/11 days any more. WADP (World Association to the Development of Philately) and UPU, as well as IFSDA (International Association of Dealers) are against this situation.

In future, with the privatization of the European Posts, we shall have a tremendous problem to get support from the postal administrations. This can also happen in the future in the other Continents.

So we have only the possibility to reduce the costs of an exhibition and this only can be done reducing the numbers of days and many times the number of countries, organizing Continental Exhibitions.

This is not only applicable to Europe, but also to Americas and Asia.

On the other hand, the dealers cannot afford anymore the financial support to be present 11 days in an exhibition, when the "chiffres of Affaires" in 5 days will be almost the same than in 11 days.

National Federations, Continental Federations and FIP must discuss this matter and present a solution to our trade partners.

I only have an objection and this will be in the exhibition where will be held FIP Congress and meetings of the FIP Commissions, but this will be one exhibition each 2 years.

FIP Board must give, through its Consultant, the best support to all FIP exhibitions and must find always a very good balance between jurors, exhibits, and partners.

FIP exhibitions are like a "philatelic circus". All are important, so we must take care about all.

8 - Seminars

Seminars organized by FIP are important. FIP Board shall have the task to promote seminars in all international exhibitions, even coming to agreement with Continental Federations to

organize FIP seminars at the Continental exhibitions.

These seminars must involve all FIP philatelic classes and a copy of these seminars, should be kept in the files of FIP.

9 - WEB Site

I consider that actual Website of FIP is in a good level.

However we must take in consideration that we must pay attention to this matter and maintain always the website actualized.

A member of FIP Board must be in charge of this matter and must have the responsibility to maintain our website with a good level of information.

10 - FIP AWARDS

FIP, the bigger world-wide philatelic organization, has prizes, but these are completely forgotten. These prizes are in the Chapter VIII of Statutes.

We must distinguish the better.

If I am elected, I will be prepared to turn alive these awards.

These awards can be agreed or supported with National Federations, according the Chapter VIII of FIP Statues.

FIP must be an international institution with live.

11 - FIP Statutes

When I was FEPA President, FEPA Board did the revision of FIP Statutes and sent this to FIP Board. FIP Board was never interested to discuss our proposals.

We have many things to correct in FIP Statutes. We must reform our FIP Statutes according the actual situation and we must turn clear all points in FIP Statutes which are in nowadays completely obscure. For example: *Continental Federation shall be represented in FIP Board.* Very well, but how? FIP Statutes do not make

any mention if must be a Vice-President, a Director.

Many other things must be revised in FIP Statutes.

If I am elected, I promise to all of you, that I will retake this matter and with FIP I will build new FIP Statutes to be discussed with Continental Federations and National Federations, where all feelings and philatelic and social situation will be taken into consideration.

12 - FIP GREX

With the Grex we have the same situation like with FIP Statutes. Together should be proposed tfor revision.

13 - Rules

Philately is not static. Philately is always in evolution. So, FIP Board must be always attentive and must organize immediately rules about the new philatelic targets. We cannot wait 4/5/6 years for rules, as happened recently with *Open Class* and *1 Frame*.

We must try to be faster. Sometimes is better to have a bad rule, than do not have any rules at all.

14 - UPU and WADP

FIP Board is member of these two world-wide organizations.

We must be always present in all meetings and a good co-operation must be maintained with these two organizations.

We must feel what they are their wishes and also to present our worries, but a team work must be done.

15 - Literature

It is obvious that FIP Board cannot support the publication of literature philatelic works. But Literature is fundamental to the support and development of the philately.

FIP Board will do all to promote and support the publication of books and FLASH must be completely open to announce and promote the works published in each country, giving the opportunity to all world-wide philatelists to buy the books which can be important for their collections and their philatelic education

16 - Youth

The work with Youth must be done directly between the Youth clubs, schools and the young girls and boys. FIP has not in this matter a great opportunity to interfere.

However, we must support all Youth events and give our best to improve the Youth philatelic world.

The FIP Commission of Youth has an important task in this matter and FIP Board must work together with this Commission and a member of the Board must be in charge of the contact with this Commission.

17 - FIP BOARD - Procedures

FIP Board should carry out a collegial work. The Statutes and Grex must be respected.

All letters, fax, e-mails ought to have always a fast answer.

All cases not fulfilled in the GREX and Statutes must be decided in FIP Board.

A code of ethic shall be created to FIP Board.

Each member will have some tasks to develop in FIP Board.

Each three months the members of FIP Board shall send to the President a report about their activity.

An annual report must be present to the National Federations.

FIP Board shall have one meeting per year and a second meeting if necessary. It is not acceptable to organize 6/7 meetings per year, because no reason can support this procedure.

FIP Board will take care about all matters of the world-wide philately and together with

Continental and National Federations will find the best solutions to the philatelic matters.

18 - FIP Commissions

FIP Commissions must receive a deep reform. This must be done in FIP Statutes.

In my opinion the only members elected should be the President and Secretary.

Each Continental Federation must present a candidate to President and Secretary. These candidates must be elected in Continental Congresses.

The Commission will elect one of the three to be President and another to be Secretary.

Afterwards, the President must be able to select the other three members, one from each Continental Federation. Why to be able to select? Because in the past we could hear many times the FIP Commission president to claim that the members elected did not work.

The FIP Commissions are essentially technical commissions, so the President will have the possibility to select people who trust and knows that are able to work with him.

Dear President, these are my proposals for the next four years, in case I am elected.

They are only few pages, but they contain a lot of work.

The only thing that I can promise you is work to improve the world-wide philately and respect my plan of action for the next 4 years.

So, you should not vote only for Pedro Vaz Pereira, but mainly for this program, which I am presenting you, if you trust in my person and in my program.

I will appreciate very much your support and together we will turn the philately a better hobby for our free time and for the continuity of the hobby itself.




Nino Aquila and Francesco Orlando (Italy) for "I francobolli dell'ultimo Re" (Sicily – The postmarks of the new King)

This book completes the trilogy about Sicily's stamps and postmarks started by Noni Aquila with "I francobolli degli ultimo Re" (The Stamps of the last King) and continued together with Franceso Orlando with "La Posta fra I due Re (Mail between the two Kings)
All published by Bolaffi.

The awarded volume describes the latest period, from May 1861 and 31 December 1863 when the new Italian stamps were introduced, in a changing postal environment also due to the establishment of a number of new post offices. The Bourbon postmarks had to be used while waiting for the new Italian ones, similar to the ones of Sardinia.

After a short introduction on the historic and postal situation the authors present the Sardo-Italian period and the relevant rates covering both the old Bourbon offices and the new established ones, providing a thorough description for each one of them with illustrations of the items and reproduction of each postmark con-cerned.

Then the book presents the Italian date postmarks available in Sicily from February 1862, again by post office. The two following chapters are devoted to the maritime mail and the mail bound abroad, which are of high importance considering that Sicily is isolated from the mainland. This elegant 464 pages book, enriched by 839 illustrations, provides a detailed analysis of each place, supplemented with additional in-depth details on the postal facts as well as with valuable information on local history and geography. A wide bibliography presents the sources of the outstanding research out over several decades by both authors.

Reinhard Metz: Georges Fouré – Die Geschichte eines genialen Philatelisten und Fälschers (The history of a brilliant philatelist and forger)




Generations of philatelic experts have spent a lot of efforts to understand the work of Georges Fouré - the name alone is legendary – represented by his manipulations, namely his forgeries. Reinhard Metz has brought together and analyzed all the texts concerning this 19th century French-German philatelist and stamp forger. In addition he is presenting both the life and work of the man in a new way, succeeding in creating an entirely new representation of his ambivalent personality and supporting his representation with a very large amount of details also of his pernicious forgery activities.

Reinhard Metz has assembled a collection of some 200 Fouré's forgeries, that has enabled him to express many new assessments and comparisons. That has enabled him to transmit very clearly his knowledge to the reader, also by showing both genuine items and around 140 Fouré's forgeries, a quantity exceeding everyone's best expectations on such a complex subject

Damir Novalovic: Stamps and Postal History of Trieste, Pola, Fiume, Istria and Slovene Littoral under Yugoslav Military Administration 1945-1947

This book is the result of nearly forty years of collecting and research undertaken by the author in this field. It analyses stamps and postal history of the area disputed between Italy and Yugoslavia, administered by the Yugoslav Army between May 1945 and the implementation of the Paris Peace Agreement on 16.09.1947. In addition to detailed description and listing of stamps, postal stationery, errors, varieties and flaws, it presents a new and original classification throughout including the re-evaluation of four hitherto neglected stamps which merit a separate catalogue entry. The overview of postal history encompasses separate surveys of post offices, cancellations, tariffs, air mail services, censorship, stampless and military mail. Brief political and historical introduction and an appendix with selected source material are included.



The Title "Posthuse & Plovmænd" Post Offices and Ploughmen – refers to two of the most welknown prints produced of the printer H. H. Tiele. The 5 kroner stamp issued in 1912 picturing the Central Postoffice in Copenhagen – and the 500 kroner bank note picturing a Ploughman with horses in front of the plough.

Thiele printed most of the Danish stamps from the beginning in 1851 and till 1932.

The book present a "never before" told story about the Printing House H. H. Thiele.

The author has been through all available information in the public arcives including those from the Post and present many exciting stories from the 166 years that this Printing House existed.

The Study No. 4 of Afinet, developed by Eugene de Quesada in Agora Philately,in February 2010, has sold out the first edition in less than one month, while a second edition will be issue shortly. The book in large format with 160 pages in color, is a serious and rigorous study on these interesting but little known and complex speculative issues.

The official presentation of the study, conducted at the Royal Mint House, had a unique call success: one hundred academics, experts and collectors from all over Spain gathered in the presentation, which highlighted the rigor of research of the work done by Eugenio de Quesada.

The annex of the study, in the form of "Guide to the identification of fake postmarks" has become a compulsory reference and effective method to differentiate the apocryphal postal history of the issue.
