#### Dear Collector Friends of the Fiscal Philately,

From May 9 to 11, the "Arbeitsgemeinschaft Fiskalphilatelie im BDPh e.V." in cooperation with the International Stamp Fair Essen and the FIP Revenue Commission wants to hold the first "Salon for Fiscal Philately" in German.

For this exhibition, the organizer of the fair will provide us with an exhibition area where we would like to present 200 frames of exhibits of worldwide Revenue Philately to visitors of the fair and of course to interested Fiscal Philatelists.

With this bulletin, we would like to inspire you to participate in the exhibition in order to show together the diversity of our hobby to the philatelic world. In addition to this salon, guided city tours, lectures and talks as well as opportunities for trading are planned. Here, however, we are also completely dependent on the registrations and feedback in order to provide the best possible location and space.

In the exhibit, everything of fiscal material can be shown - prescriptions on sheet sizes, contents, structure will not made - the motto is: "**Build your fiscal collection** according on your own criteria and show them in the salon". The only requirement for the construction of your exhibit is that the exhibition frames have a size of 1 square meter. We will also provide showcases and options for displaying 3D objects.

In addition to the fiscal material, the exhibit may also be supplemented with nonphilatelic material (regulations, photographs, maps, heraldic, etc.), which the exhibitor considers helpful in enriching the content of his exhibit and, above all, in explaining it.

This salon takes place without any evaluation in order to limit the creativity of the exhibitor. In addition, it is planned that a team of experienced Jurors will provide tips and recommendations for later participation in competitive exhibitions. New ideas and approaches are presented to the BDPh and the FIP. This gives the opportunity to stimulate improvements to the exhibition regulations and assessment guidelines. An unofficial evaluation sheet may be asked for by the exhibitor.

The ArGe Fiskalphilatelie e.V. celebrates this year its 30th society anniversary and the first planning took place in 2017. With the support of the BDPh and the FIP this event can now be realized and we are happy to show our hobby to the broad public. "Social and Open philately" are modern slogans in postal philately, how well these suit the revenue material! In Thematic philately, fiscal material belongs to "border line material" and so far is hardly accepted. But illustrations, usages and documents offer an incredible range of thematic treatments.

By help of your participation we will be able to show outstanding studies of traditional revenue exhibits and we look forward to see a variety of new innovative approaches. Your creativity as an exhibitor will have no limitations.

#### Terms of the Exhibition

- 1. Anyone who has a collection of tax, fee, duty or revenue stamps or any other non-postal stamps and has designed and built them according to his / her criteria can exhibit.
- 2. Everything that belongs to the field of fiscal philately may be shown. Documents and entries are expressly desired. Material that is important for explanation and classification may also be shown.
- 3. In addition to individuals, groups may also participate. The group will then be mentioned in the catalogue
- 4. The standard exhibition frames in Germany, measuring approx. 96 cm x 96 cm, will be made available.
- 5. A frame provides space for 3 rows of 4 album pages (width: 240mm, height: 297mm) as standard. Any other division of the frame area with oversize and different page sizes is allowed.
- 6. An exhibit should have a scope of at least 1 to a maximum of 10 frames.
- 8. Mounting and dismounting takes place in agreement with the exhibition management by the exhibitor himself or by members of the Arbeitsgemeinschaft.
- 9. The exhibitor is responsible to have an insurance in place of his exhibition during the transport and during the exhibition.
- 10. The salon takes place without evaluation of the exhibits. An unofficial evaluation can be made at the request of the exhibitor.
- 11. The deadline for registration is November 30th, 2018.
