TimFilEx 2025 REGULATIONS

Art. 1 – PURPOSE OF THE EXHIBITION

TimFilEx 2025 is a national general philatelic exhibition, with international participation, for collectors from FEPA affiliated countries.

Art. 2 – ORGANIZATION, DATA AND PLACE

2.1 TIMFILEX 2025 is organized by the Philatelic Association of Timișoara and the West University of Timișoara and is guided by the Regulations of the International Federation of Philately (FIP) in force. TIMFILEX 2025 is managed and led by an organizing committee.

2.2 The exhibition will open on November 21, 2025 and close on November 23, 2025. *The exhibition marks 150 years since the birth of Queen Marie of Romania.*

2.3 The exhibition will take place at the West University of Timisoara. Approximately 300 frames will be available.

Art. 3 – RECOGNITION AND APPLICABLE REGULATIONS

3.1 TimFilEx 2025 is a national exhibition with international participation, organized under the patronage of the Romanian Philatelic Federation.

3.2 The following regulations shall be applicable to TimFilEx 2025:

- The General Regulations of the FIP for Exhibitions (GREX),
- The General Regulations of the FIP for Evaluation of Competitive Exhibits at FIP Exhibitions (GREV),
- The Special Regulations for the Evaluation of Competitive Exhibits at FIP Exhibitions (SREV),
- The Individual Regulations of TimFilEx 2025 (IREX).
- In case IREX deviates from GREX, GREV or SREV, IREX shall apply.

Art. 4 – CONDITIONS OF PARTICIPATION

4.1 Competitive Classes:

Exhibitors who are members of national federations/ societies/ associations of the Fédération Europeene de Philatélie (FEPA) are eligible for participation. An exhibitor who satisfies the following may submit entry form:

- Exhibits winning at least 75 points or a vermeil award at national exhibitions during the last 5 years prior TimFilEx 2023, (for classes 2-13 according to Art. 5.2).
- For exhibits in the literature class no previous award is required. Books must have been published within the previous five years and all other entries in the literature class within the two previous years. The qualifying date being the 1st of January 2023.
- New exhibits.
- For Exhibits in the Youth class, qualification is done according to age groups:
 - A (10 to 15 years).
 - B (16 to 18 years).
 - C (19 to 21 years).

4.2 Non-competitive classes:

Entries in non- competitive classes shall be by special invitation at the discretion of the Organizing Committee.

Awards are presented by points (60 to 100 points) and awarded by certificates only. No medals will be awarded.

Certificate of Participation will be given to exhibits attaining less than 60 points. Exhibits will be classified under:

C) Postal stationary

D) Aerophilately

E) Astro philately

F) Thematic

G) Revenue

H) Open

I) Maximaphily

J) Picture postcards

E) Article (collection of, published since 2020)

F) Digital literature, websites, and software as experimental class

Class 14A– 14E literature can be submitted in either printed or digital form.

Art. 6 – JUDGING OF EXHIBITS AND AWARDS

Exhibits in Competitive Classes will be judged by appointed and accredited jurors in accordance with principles laid down in GREV and SREV.

Art. 7 – FRAME SIZE AND ALLOTMENT OF FRAMES

7.1 The exhibition frames of TimFilex 2025 shall be 99 cm x 120 cm. Each frame shall have a capacity for 16 A4 sheets (four sheets in four rows – 4 x 4) enclosed with a transparent protective cover no more than 197 mm high and 140 mm wide. All sheet formats accepted by FIP are allowed.

7.2 All exhibits must be mounted on white or light-coloured pages.

No exhibit must be mounted on dark coloured or black sheets will be accepted.

7.3 In case the existence in an exhibit of expertizing certificates, the original or a certified copy issued by the National Expertizing Federation must be placed at the disposal of the jury by inserting it at the back of the page. The existence of a certificate should be noted by a small “c”.

7.4a Every exhibit shall be allotted 5 or 8 frames. Exceptions are possible; not only at classes 12 and 13).

7.4b Class 10: Experimental class: 1, 2 or 3 frames;

Class 13: Youth philately

Group A 1-3 frames

Group B 2-4 frames

Group C 3-5 frames

Five frames shall be allotted to exhibits that obtained at least a vermeil award at the national level.

Six, seven or eight frames shall be allotted to exhibits that obtained at least a large vermeil price at FIP exhibitions (under FIP patronage and/ or FIP recognition).

Art. 8 – APPLICATIONS AND ACCEPTANCE

8.1 Exhibitors shall fill in one Application Form for each exhibit and to provide it at the Organizing Committee by 1st of August 2025.

8.2 The Organizing Committee shall have the authority to accept or to reject the application without specifying the reason.

8.3 Notification of acceptance or rejection, together with the number of allotted frames, shall be transmitted to the exhibitor by the Organizing Committee by 1st of September 2025.

Art. 9 – ENTRY FEES

9.1 There is no fee for non-competitive class entries.

9.2 The participation fee for competitive classes is 10 EUR per frame. (Except class 13 and 14).

9.3 Participation at youth philately class (Class 13) is free of charge.

9.4 Participation fee at Philatelic Literature class (Class 14) is 25 EUR per exhibit.

Art. 10 – HANDLING OF EXHIBITS

10.1 In case an exhibit is delivered late or in case the sheet size does not comply with the provisions of Art.7.1, the exhibit will not be judged, and the participation fee shall not be refunded.

10.2 Each sheet shall be placed in a transparent protective cover, numbered in the lower right corner.

10.3 Each exhibit shall be delivered in envelope/ folder (one per frame). The inventory sheet shall be put in the envelope of the first frame.

10.4 The accepted exhibits shall arrive to the Organizing Committee no later as November 10, 2025.

Art. 11 – MOUNTING AND DISMOUNTING OF EXHIBITS

11.1 Mounting and dismounting of exhibits shall be made by or under supervision or Organizing Committee.

11.2 Requests to return or dismounting of an exhibit during exhibition period are not accepted.

Art. 12 – SECURITY MEASURES

The Organizing Committee shall take all measures to assure the security of exhibits from arrival to the return of them. The Organizing Committee is not responsible for any damage or losses which could appear during transport to and from exhibition.

Art. 13 – RIGHTS OF ORGANIZING COMMITTEE

13.1 It is considered that each exhibitor applying for TimFilEx 2023 accepted IREX stipulations.

13.2 The Organizing Committee shall have the right to judge any appeared problems, which are not under jurisdiction of FIP or IREX regulations, and its decisions shall be definitive.

Art. 14 – ACCEPTANCE OF THESE REGULATIONS

By signing the Exhibit Application Form, the exhibitor shall be deemed to accept the stipulations of IREX, GREX, GREV and SREV.
